Please find attached an "Application for access to Sydney Catchment Authority Special Areas/Controlled Areas/Water Storages" form duly completed.

As the photo taken at Darkes Forest above shows, a "Special Area" exists. However, whilst residents are specifically excluded unless the above application is approved, mining and petroleum company's have unlimited access to these types of areas. Why would that be so and what can't the public see?

I believe it is in the public interest that the public should be aware what is happening in "it's" backyard and whilst I can appreciate appropriate security measures, inspections of such lands must at times be transparent to the public.

Residents have expressed concerns that the operations are not conducted in accordance with the License and are being breached. The inspection would also be to ensure that Sydney Catchment Authority is issuing breach notices on Licensee's where appropriate.

Therefore, I look forward to your approval of my application to inspect these lands "in the community interest" promptly. This application and your reply will be posted on the website www.gregpetty.com.au in due course as part of my election platform for greater public transparency in government decision making. Written reports and photographic record (2 cameras of same shots) will be supplied to SCA.
